#### The Donors' Education Collaborative welcomes new members.


For 20 years, The Donors' Education Collaborative (DEC) has brought funders together to support efforts to improve the New York City public school system for *all* of its students. With 1.1 million students in more than 1,800 schools, the City's public school system is the largest district in the United States. Nearly every New Yorker has a stake in the public schools, and the system's innovations, successes, and failures are watched closely throughout the country. Improving our schools is a daunting task, but DEC provides a way for funders to face that challenge together.

By pooling funds, drawing on our members' and staff's expertise in education, making grants collaboratively, and supporting strategic policy initiatives, we've made our education system better for a diverse student body, increased State funding for schools, and decreased suspensions Citywide. But there is more to be done.

### 20 Years of Results for New York City Schools

The Donors' Education Collaborative is dedicated to the improvement of New York City's public schools through system-wide policy reform. It supports advocacy to advance equity, opportunity, and excellence for *all* students—including those facing the greatest challenges. Members share a belief that effective and lasting reform is grounded in research and carried out in partnership with parents, students, educators, and community members. With this grantmaking strategy and an understanding that sustainable change takes time, DEC's investments over the years have improved education in New York.

- DEC-funded A+ NYC Coalition worked with diverse communities to develop and advocate for an education
  policy platform during the 2012 and 2013 mayoral campaign. The Coalition's recommendations were adopted
  by the de Blasio Administration, including: expanded pre-kindergarten and afterschool programs; more
  community schools; reformed school discipline and policing; and strengthened involvement of parents in
  schools.
- Funding for the **NYC Coalition for Educational Justice** helped organize low-income parents of color, immigrant families, and students in education reform. These communities are now regular participants in policy discussions. The coalition's most recent accomplishment is a renewed commitment to parent engagement by the Department of Education.
- After years of DEC-funded advocacy by the Alliance for Quality Education and the Campaign for Fiscal Equity,
  New York State enacted a number of reforms in its State Education Budget and Reform Act of 2007, including
  a large increase in aid to schools across the state, and a more equitable funding formula for school aid based
  on student need.
- With DEC funding, The Dignity in Schools Campaign New York won revisions to the City's School Discipline
  Code, reducing the emphasis on automatic suspension while increasing help for struggling students. As a
  result, suspensions have decreased by 39% since the 2010-2011 school year.

### **Current Priorities**

In late 2013, DEC invited proposals for projects to advocate for system-wide policies to increase equity, excellence, and collaboration among groups in the City public school system. In 2014, DEC awarded grants to: Advocates for Children of New York • Alliance for Quality Education • Asian American Legal Defense & Education Fund / New York Appleseed • Brooklyn Movement Center • Dignity in Schools Campaign – New York, led by the National Economic and Social Rights Initiative • Make the Road New York • New Settlement Apartments' Parent Action Committee • NYC Coalition for Educational Justice • New York Civil Liberties Union • ExpandED (formerly The After-School Corporation) with the NYC Coalition for Educational Justice, Generation Schools Network, and the National Center on Time and Learning • The New School's Center for New York City Affairs. Most of these grants were renewed in 2015.
